

LIFE COACH AGREEMENT

TERMS AND CONDITIONS

This document spells out the agreement between parties. Christian Family Network is a service provider of training and resources of empowerment for the entire family. Christian Family Network is hereinafter referred to as "Provider." The second party being the guardian, parent, relative or unrelated sponsor and responsible for the payment of services rendered is, hereinafter, referred to as "Guarantor." The son, daughter or person being sponsored by Guarantor will, hereinafter, be referred to as "Student."

The following term and conditions stipulate the cost and term for services. The Christian Family Network model utilizes a team of Life Coaches of which are all trained and certified through the Parenting Workshop Training Academy. The following breakdown describes the role of each Life Coach.

- A Home Life Coach is given temporary legal guardianship and acts as a surrogate parent for a short season.
- A Treatment Life Coach employs the Second Chance 5 Point Treatment Plan with the Student.
- A Parental Life Coach will be assigned to the parent(s) as the main point of contact and undergo parenting training.
- A School Life Coach guides the Student in their academic and/or vocational program.
- A Youth Life Coach informally befriends the Student and offers indirect mentoring through social relationship.
- A Career Life Coach is optional and can provide Student with a psychological employment assessment and career guidance.

Student will not require any additional money but most parents do send money for snacks and extras. If you elect to do so Parent(s) are not to give money directly to the student but to allow the Life Coach to offer odd jobs that require earning the money that parents send unbeknownst to the student. This will eliminate a sense of entitlement. Vehicles, laptops and cell phones MUST be discussed with your Life Coach before promising your child any of these things. At times Phase II students may have a vehicle. We do not allow a student to own a vehicle in their own name just in case the vehicle needs to be repossessed.

PHASE I: INTENSIVE MENTORSHIP

The **Intensive Mentorship** phase is designed to provide "high-level mentorship" while a Student is receiving outpatient treatment. In this phase, Students' follow a regimented schedule. Students participate in classes that cover each of the Five Points in the treatment plan. Accredited k-12/college studies, life skills, group sessions, social events, and recreation are all included in this package. In addition, Students' also receive informal and individual mentoring sessions from a Youth Life Coach throughout the week:

PAY-AS-YOU-GO: \$6,900 per 30 days. Term: 30 days, (Minimum, no obligation), 60 days, or 90 days (Maximum)

SPECIAL DISCOUNT: \$25,000 for 6 months. Receive a plethora of value if you pay for the complete Life Coach Package in advance. You will see as detailed below that a 90 day Phase I and a 6-month Phase II track will cost you a total of \$39,300 if you pay monthly. Thanks to The Father's Heart Foundation, a sponsorship is being offered for a limited time. Your cost is \$25,000 if paid in advance. This will give you a savings of \$14,300. We are so confident in this Life Coach Package that we are also offering a *pro-rated refund if for any reason at all, you should decide to withdraw your child after the first 90 days. If you would rather pay monthly without obligation, see below, for monthly cost for each phase. The refund policy does not apply to the monthly pay-as-you-go option. Refund is pro-rated per day after the initial 90 days and is based upon the cost of the respective phase.

PHASE II: TRANSITIONAL MENTORSHIP

LIFE COACH AGREEMENT

The **Transitional Mentorship** is designed to provide “moderate-level mentorship”, as preparation to “low-level mentorship.” In this phase, Students are challenged to take responsibility as they earn more privileges. Students continue to participate in activities that review the parts of the Five-Point Treatment Plan. Students are given volunteer opportunities within the church and community and may participate in special outings or trips. Accredited k-12/college studies, life skills, group sessions, social events, and recreation are all included in this package. Students continue to receive mentoring sessions throughout this phase:

COST: **\$3,100 per month** (6 months tuition paid upfront and in advance)

PHASE III: COMMUNITY INTEGRATION

The **Community Integration** is designed to provide “low-level mentorship” while a Student integrates back into everyday life. In this phase, Students live out their recovery while working a job and/or going to high school/college. Students are required to report to their leaders and remain accountable at all times. They continue to be involved in church services, fellowship and activities as well as volunteer opportunities within the church and community.

- Guaranteed job with a paid position
- Life skills coaching
- Ongoing education and personal development assistance
- Career development
- Protected marketplace environment
- On-site personal and group support
- Term: Minimum 6-months
- Cost: **\$3,100 per month**

ADDITIONAL SERVICES

Please review this listing of al-a-carte services that we offer for additional costs. Contact your Life Coach or Enrollment Counselor as to which services may be beneficial to your specific circumstance.

Detoxification

- 72 hours of supervised care, nourishment, and rest
- Cost: **\$1,000 plus expenses** (Travel, meals and accommodations including detox team members)

Teen Transport & Escort Service

- Two licensed chaplains with badges
- For uncooperative adolescents
- Includes a one-day excursion. Multiple days are \$500/day
- Cost: **\$2,500 plus expenses** (Flight, car rental, lodging, meals)

EXTRACURRICULAR ACTIVITIES

In some instances Student will have the option to go on social enrichment, religious functions, educational excursions, recreational opportunities or entertaining outings, which are not covered in the tuition. In such cases the Guarantor will be required to cover the necessary registration or admission fees.

EXPENSES NOT COVERED

Guarantor will maintain medical and dental insurance at all times and be responsible for all medical, dental and optical expenses; to provide all clothing and to pay for property damaged or stolen by Student. Failure to promptly pay and/or reimburse Provider for any of these expenses may be cause for dismissal.

DUE AND PAYABLE

Guarantor must pay tuition prior to the beginning of Student's term. Provider can provide a receipt upon request. Any late monthly payment will result in Student returning home immediately.

PHASES

It is our goal to reflect fruits of love, long suffering, mercy and patience without compromising our authority and our commitment to discipline when necessary. In cases where the Student abuses Phase 2 or 3 privileges and is either unable or unwilling to apply the teachings and use the tools of treatment, we reserve the right and, at our discretion, to demote Student back to phase 1. The cost of Phase 1 will begin accruing at that time and the account will be debited accordingly. This applies to discount Life Coach Packages as well.

EXPULSION

It is not the policy of Provider to expel a Student for behavioral defiance or acts of incorrigibility. There are, however, few and rare circumstances under which a Student may need to be returned back home. Therefore, Provider reserves the right to expel any Student for refusal to comply with any rules or regulations. In the event of expulsion, Guarantor shall have the right to file an appeal with Provider within 30 days.

REFUND POLICY

This agreement is a serious commitment and is intended to help Student with spiritual and life controlling problems. Payment requirements for the full Life Coach Package remain in effect even if Guarantor decides to terminate services with Provider. ***This is a non-refundable Life Coach Package.***

There are, however, valid reasons for a refund of monies or credit for future services. They are as follows:

- Student dies
- Act of God
- Permanent expulsion
- \$25,000 paid in advance

A pro-rated refund of tuition will be honored ONLY if it is paid upfront and in advance for a total of \$25,000. Refund conditions are as follows:

1. Withdrawal must be signed and notarized in order to take effect by a legal parent or the student if he/she is an adult in the case where a refund is requested otherwise a written or verbally expressed withdrawal will suffice.
2. Only a Primary Guarantor(s) can withdraw a Student from the Provider's treatment program. If Student is a minor he/she cannot check him or herself out of the program, therefore ***the Student's choice for wanting to be in the program or not does not constitute a valid reason for a termination of agreement and refund.***
3. The initial 90 days are not refundable
4. Allow 30-45 days for processing of refund
5. Pro-ration figures are based upon actual cost breakdown as detailed in the program phase described herein.
6. Refund policy becomes null and void if the authority of any staff member or rule is undermined by parents, relatives or authorized acquaintances. Undermining also happens when implied or direct influence and lifestyle of parents, relatives and authorized acquaintances dishonor "The 20 Principles", "5 Point Treatment Plan", "The Believers Covenant" and

“The 7 Laws of Kingdom Citizenship.” Furthermore if the “Personal Property” and “Spending Money” section of the Enrollment Application is violated, the refund policy will become null and void.

ENTIRE AGREEMENT

This Agreement supersedes any and all agreements, either oral or in writing, between the parties hereto with respect to the rendering of services by the Provider, and contains all of the covenants and agreements between the parties with respect to the rendering of such services in any manner whatsoever. Each party of their agreement acknowledges that no representations, inducements, promises or agreements, orally or otherwise, have been made by any party, or anyone acting on behalf of any parties, which are not embodied herein, and that no other agreement, statement, or promise not contained in this Agreement shall be valid or binding. Any modification of this Agreement will be effective only if it is in writing and signed by the party to be charged.

SEVERABILITY

If any provision of this Agreement is held by a court of competent jurisdiction to be invalid, void, or unenforceable, the remaining provisions shall nevertheless continue in full force without being impaired or invalidated in any way.

GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the state laws.

INDEMNIFICATION

The Guarantor(s) agrees to indemnify Christian Family Network, LLC and/or assigns, its employees, nominees, officers, directors, affiliates or volunteers from and against all actions, proceedings, claims or demands which may be made by reason of act, deed, matter or thing done or omitted to be done by any one of them and to pay all costs and expenses which may be incurred in the connection with any such action, proceedings, claims or demands.

PAYMENT

It has been our experience that medical insurance policies do not cover our network of programs. We have been advised that the reason for denial of coverage is simply because we are not a medical facility. Denial of an insurance claim does not constitute a refund of the tuition in its entirety or any portion thereof.
